MiRegistry is now PER Approved

MiRegistry has successfully completed the National Workforce Registry Alliance (NWRA) Partners in Employment Reporting (PER) recognition process.



The PER recognition process assesses the state's registry operations to determine if their policies and procedures meet high-quality standards and promote best practices for data collection.

As a PER state, registry data collected from the Michigan workforce is recognized, assessed, and incorporated into a national dataset to analyze trends, draw connections between education and wage, inform policy at the state and national levels, influence workforce initiatives and allocation of funds, and strengthen collaboration with other national partners.

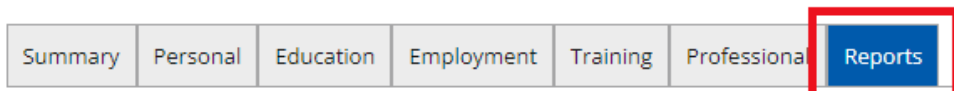
New Individual Qualified Professional Development Report
